We also talked about the service structure and how being an informed GSR can help influence what goes on in NA all around us. I did take notice that the same faces attend these things while others always struggle with understanding what goes on in NA service. That was even some of the feedback we have been getting.

On a regional note, we attended the Assembly in Prescott a couple of weeks ago and it had several SEAZNA members there. We did some writing/discussing of the Tradition Workbook that is in review at this time. A lot of us seem to feel we are not really finished yet with this book and it needs much more input. Our website is working on some issues that help you navigate more clearly such as finding insurance forms and such.

ARCNA (present) chair is suggesting we scale down our fundraisers since they seem to be losing money more of the time than not. The Convention Committee and BOD are looking into this. We are sharing the "Human Resource" forms for anyone looking to be involved in various projects at that level. We are also working on Subcommittee surveys in our area to have region better understand how they can serve us. A side note, we made a donation of \$5k to the world service conference last month.

We are working on hosting the next Assembly in October in Sierra Vista. We will talk with the local Fellowship to find a place down there possibly for the 24th of Oct. The RDs are also (at our request) putting a bid in for having the Western States Zonal forum in Tucson or Phoenix in 2017! This WILL be a big deal if

we get it. Our Zone stretches from Alaska to So Cal. Since the WSC and NAWS are asking for us to consider "Zonal Representation", we may want to learn more about this.

PUBLIC RELATIONS:
